- LOCATION:** 3623 Club Drive, DePere WI, 54115
- FACILITIES:** 12 firing point indoor range with turning targets at 50 feet. Food & beverages available at the range club house.
- ELIGIBILITY:** Open to any member of the National Rifle Association
Competitors **MUST** furnish proof of eligibility.
- ENTRIES:** Entries will be limited to 48 competitors, 24 per day.
Entries will be confirmed upon receipt of the completed registration from. Please complete all blanks.
Registration fees accepted via Mail or when checking in at the range.
- MATCH ENTRY FEES:** Registration fee is \$10.50 (\$4.50 to NRA and 6.00 DPSC)
Individual matches are \$2.25 each
ACROSS-THE-BOARD ENTRY (including registration) is \$35.00
- RELAYS:** Relay #1 - Saturday 9AM. Relay #2 - Saturday 2PM.
Relay #3 - Sunday 9AM. Relay #4 - Saturday 2PM. There will be approximately 1/4 hour break between 22 & CF and approximately 1 hour lunch break between relays
- RULES:** Current NRA pistol rules will apply.
- SCORING:** Competitors will score and change targets. Scoring plugs will be restricted to range personal only. A fee of \$2.00 will be charged for each challenged target. Fee will be returned if challenge is sustained.
- CLASSIFICATION:** NRA classification system will be used. Any class with less than five entries will compete in the next higher class. If there are less than five entries in the master class, they will compete for match winner only.
- SAFETY:** **USE OF EYE AND EAR PROTECTION IS REQUIRED BY ALL COMPETITORS.**
